Selecting fine audio equipment such as the unit you've just purchased is only the start of your musical enjoyment. Now it's time to consider how you can maximize the fun and excitement your equipment offers. This manufacturer and the Electronic Industries Association's Consumer Electronics Group want you to get the most out of your equipment by playing it at a safe level. One that lets the sound come through loud and clear without annoying blaring or distortion and, most importantly, without affecting your sensitive hearing. Sound can be deceiving. Over time your hearing "comfort level" adapts to higher volumes of sound. So what sounds "normal" can actually be loud and harmful to your hearing. Guard against this by setting your equipment at a safe level BEFORE your hearing adapts.

To establish a safe level:

- Start your volume control at a low setting.
- Slowly increase the sound until you can hear it comfortably and clearly, and without distortion.
- Once you have established a comfortable sound level. Set the dial and leave it there.

Take a minute to do this now will help to prevent hearing damage or loss in the future. After all, we want you listening for a lifetime.

Used wisely, your new sound equipment will provide a lifetime of fun and enjoyment. Since hearing damage from loud noise is often undetectable until it is too late, this manufacturer and the Electronic Industries Association's Consumer Electronics Group recommend you avoid prolonged exposure to excessive noise.

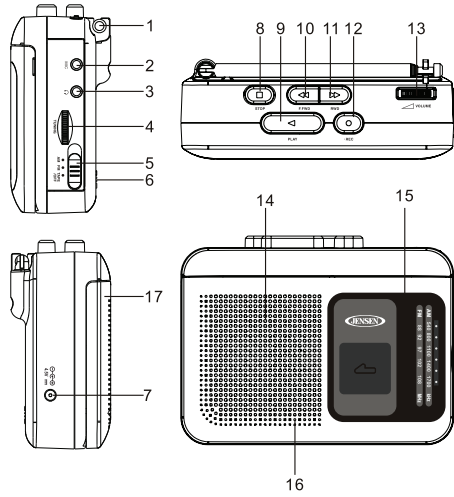

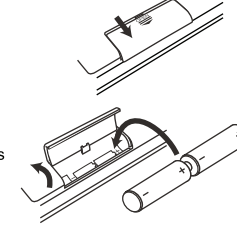

POWER SOURCE

This cassette player operates on two 1.5V DC "AA" size (UM-3) alkaline batteries (Not Included) or with an AC-DC adaptor with 4.5V DC 350mA output (Not Included).

BATTERY OPERATION (BATTERIES NOT INCLUDED)

- Open the battery door located on the back of the unit.
- Follow the polarity diagram (+ and -) shown on the back of the cabinet, and insert 2 "AA" (UM-3) batteries (not included), and close the battery door.



IMPORTANT: Be sure that the batteries are installed correctly. Wrong polarity could damage the unit and void the warranty.

- Notes:**
- If you are using an AC Adaptor (not included), please unplug it from the unit before installing the batteries.
 - For best performance and longer operating time, we recommend the use of good quality alkaline battery.
 - The batteries need to be replaced when if the volume level becomes significantly lower, if the sound is distorted during operation or the unit no longer functions properly.

BATTERY WARNING

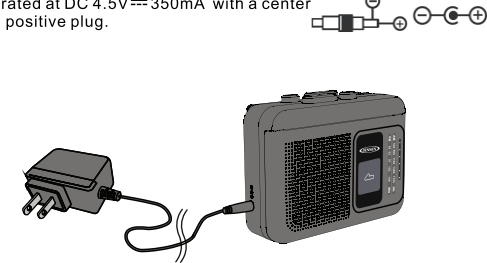
- Be sure the batteries are installed correctly. Wrong polarity may damage the unit.
- Use only the size and type of batteries specified.
- Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium) batteries.
- If the unit is not to be used for an extended period of time, remove the batteries. Old or leaking batteries can cause damage to the unit and may void the warranty.
- Do not try to recharge batteries not intended to be recharged; they can overheat and rupture. (Follow battery manufacturer's directions).
- Do not dispose of batteries in fire, batteries may leak or explode.

AC ADAPTOR OPERATION (AC ADAPTOR NOT INCLUDED)

- Plug the cord of the AC adaptor into the DC IN JACK (#7) of the unit.
- Plug the AC adaptor into a household 120V/60Hz AC power outlet.
- The batteries will automatically disconnect when the AC adaptor is plugged into the unit and the unit will operate using the AC adaptor power.

NOTE: Only use adaptor with an output voltage rated at DC 4.5V±350mA with a center positive plug.



RADIO OPERATION

- Set the FUNCTION SWITCH (#5) to AM or FM position.
- Turn the TUNING KNOB (#4) to select the desired radio station.
- Adjust the VOLUME CONTROL (#13) to obtain the desired sound level.
- To turn the radio off, switch the FUNCTION SWITCH to "TAPE" position.

TIPS FOR BEST RADIO RECEPTION

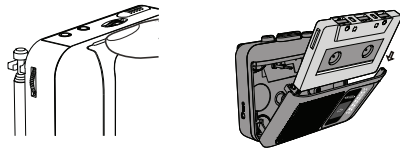
- The Telescopic Antenna should be fully extended to get the best FM reception.
- When using the AM radio, be sure to place the unit in a vertical position. For best AM reception, keep turning the unit slowly while keeping it vertical until the best signal is obtained.

CASSETTE PLAYER OPERATION

CASSETTE PLAYBACK

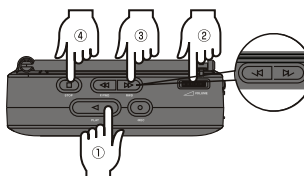
- Open the CASSETTE DOOR (#17) and insert a pre-recorded cassette tape with the exposed tape facing upwards then close the CASSETTE DOOR.



- Set the FUNCTION SWITCH (#5) to "TAPE" position.



- Press the PLAY BUTTON (#9) for tape playback.
- Adjust the VOLUME CONTROL (#13) to obtain the desired sound level.
- Press the FAST FORWARD BUTTON (#10) or REWIND BUTTON (#11) to quickly advance or rewind the tape.
- Press the STOP BUTTON (#8) at any time to stop playback. The tape playback will stop automatically when the end of the tape is reached.

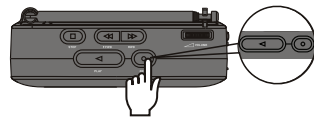
AUTOMATIC STOP

This unit is equipped with an Automatic Stop System to protect your cassette tapes and prevent unnecessary wear to the pinch roller of the cassette mechanism. When the tape ends during playback, the PLAY BUTTON (#9) will automatically release to stop the cassette from running.

CASSETTE RECORDING

Recording from the built-in microphone

- Open the CASSETTE DOOR (#17) and insert a blank cassette tape.
- Press the RECORD BUTTON (#12) and PLAY BUTTON (#9) down at the same time and the unit will start recording from the built-in microphone.
- Press the STOP BUTTON (#8) to stop recording.
- To listen to what was recorded, press the REWIND BUTTON (#11) to rewind the tape and then press the PLAY BUTTON (#9) to hear what was recorded.



Recording from an external microphone (not included)

- Plug an external microphone (not included) into the external microphone jack (#2).
- Open the CASSETTE DOOR (#17) and insert a blank cassette tape.
- Press the RECORD BUTTON (#12) and PLAY BUTTON (#9) down at the same time and the unit will start recording from the external microphone.
- Press the STOP BUTTON (#8) to stop recording.
- To listen to what was recorded, press the REWIND BUTTON (#11) to rewind the tape and then press the PLAY BUTTON (#9) to hear what was recorded.



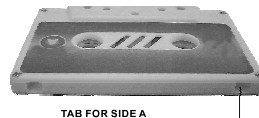

Recording from the radio

- Set the FUNCTION SWITCH (#5) to AM or FM and tune in the station you want to record using the tuning knob (#4).
- Press the RECORD BUTTON (#12) and PLAY BUTTON (#9) down at the same time and the unit will start recording from the radio.

NOTES:

- The unit features Auto Level Control (ALC), so the volume control (#13) does not affect the sound level when recording. When recording from either the built-in microphone or when using an external microphone, keep the microphone approximately 2 - 3 inches from the source that you are recording.
- You may receive some interference when recording from the AM radio.
- PROTECTION AGAINST ACCIDENTAL ERASURE:** When you record on a cassette, the previous recordings are erased automatically. To protect them against any risk of accidental erasure, cassettes are provided with protective tabs for this purpose. Remove the protective tab (or both) located at the top of the cassette using a knife or a screwdriver. If you subsequently need to re-record on a cassette protected in this way, you can cancel this protection by covering the hole revealed with a piece of adhesive tape. It is not possible to press the RECORD button if the protective tab has been removed and has not been replaced by adhesive tape.



- Do not force down RECORD BUTTON (#12) if the tape's erase-protection tabs have been removed, or you will damage the recorder.

USING EARBUDS (NOT INCLUDED)

Plug a pair of earbuds (not included) into the HEADPHONE JACK (#3) to listen to the radio or a tape in private. The built-in speaker automatically disconnects when the earbuds are plugged in.

CAUTION

- AVOID EXCESSIVE VOLUME LEVELS FOR LONG PERIODS OF TIME LEVELS WHEN USING THE HEADPHONES. PROLONGED USE AT HIGH MAY IMPAIR YOUR HEARING.
- Do not use earbuds while operating a motorized vehicle, as it may create a traffic hazard and is illegal in many areas.

CARE AND MAINTENANCE

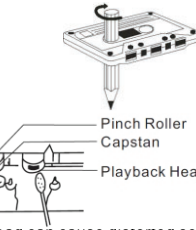
- Do not subject the unit to excessive force, shock, dust or extreme temperature.
- Do not tamper the internal components of the unit.
- Clean your unit with a dry cloth. Solvent or detergent should never be used.
- Avoid leaving your unit in direct sunlight or in hot, humid or dusty places.
- Keep your unit away from heating appliances and sources of electrical noise such as fluorescent lamps or motors.

CAUTION: Never allow any water or other liquids to get inside the unit while cleaning.

CASSETTE TAPE OPERATING TIPS

- High quality tapes are recommended to obtain maximum quality reproduction from recordings.
- Tapes with playing time of 120 minutes (C-120) are not recommended because they contain thinner and longer tape that has a greater chance to malfunction and jam, which may damage the cassette mechanism.
- To obtain good reproduction, the head should be cleaned after every 10 to 20 hours of use. It is also recommended that the cassette be kept away from excessive heat or cold.

- If there is slack in the tape, remove the slack prior to inserting the cassette. To remove the slack, insert a pencil into the hub and rotate clockwise.
- A leader tape is provided at the beginning on each cassette. There is no recording on this area, so it is necessary to let the tape run for about five seconds to clear the head.
- Keep the tape head clean since a dirty head can cause distortion or improper tape speed. Depress the PLAY BUTTON (#9) and use a small cotton swab with tape head cleaner or alcohol to clean the tape head, capstan and pinch roller.
